COMPLAINT TO CONTEST ELECTION

1. This is an action to contest the candidacy of Albert Gore Jr. and Joseph I. Lieberman in the Presidential election in the State of Florida, for all counties in the State of Florida, based on Voter Fraud, pursuant to:

102.168 Contest of election.--

(3) The complaint shall set forth the grounds on which the contestant intends to establish his or her right to such office or set aside the result of the election on a submitted referendum. The grounds for contesting an election under this section are:

(d) Proof that any elector, election official, or canvassing board member was given or offered a bribe or reward in money, property, or any other thing of value for the purpose of procuring the successful candidate's nomination or election or determining the result on any question submitted by referendum.

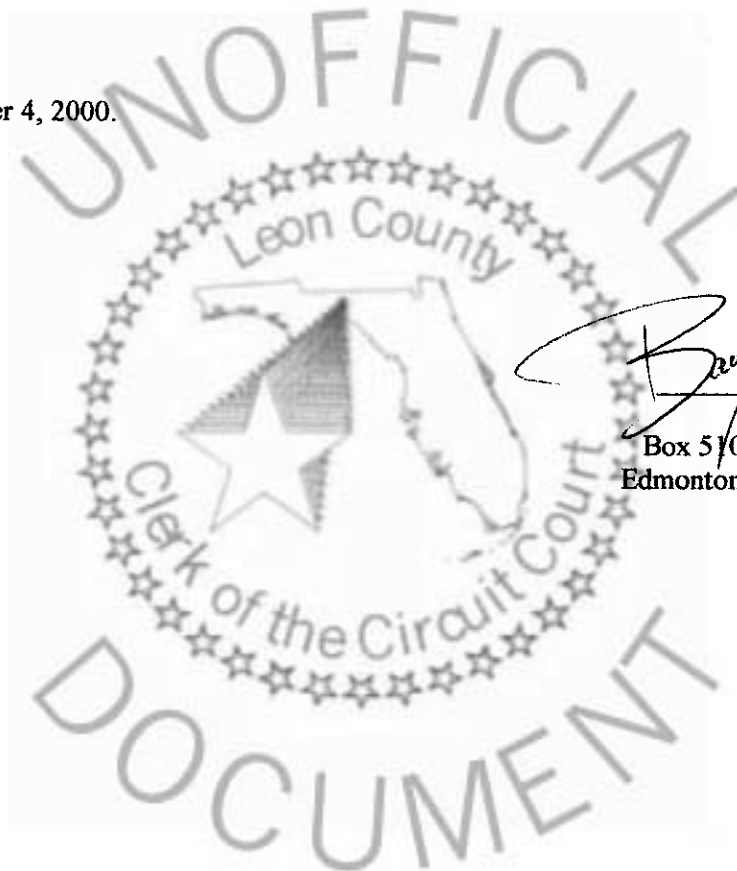
2. The particulars are included in the attached document (Exhibit A).

WHEREFORE, Plaintiff prays that the court:

VOTER FRAUD COMPLAINT

I would like to make a complaint of voter fraud against Mr. Al Gore.

The applicable sections are:

104.045 Vote selling.--Any person who:

(1) Corruptly offers to vote for or against, or to refrain from voting for or against, any candidate in any election in return for pecuniary or other benefit; or

(2) Accepts a pecuniary or other benefit in exchange for a promise to vote for or against, or to refrain from voting for or against, any candidate in any election,

is guilty of a felony of the third degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084.

104.051 Violations; neglect of duty; corrupt practices.--

(1) Any official who willfully violates any of the provisions of this election code shall be excluded from the polls. Any election official who is excluded shall be replaced as provided in this code.

(2) Any official who willfully refuses or willfully neglects to perform his or her duties as prescribed by this election code is guilty of a misdemeanor of the first degree, punishable as provided in s. 775.082 or s. 775.083.

(3) Any official who performs his or her duty as prescribed by this election code fraudulently or corruptly is guilty of a felony of the third degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084.

(4) Any supervisor, deputy supervisor, or election employee who attempts to influence or interfere with any elector voting a ballot commits a felony of the

These Executive Orders are also in violation of:

Government hiring is to be merit based, 5 U.S.C. Sec. 2301. Merit system principles, (b) Federal personnel management should be implemented consistent with the following merit system principles:, (2) All employees and applicants for employment should receive fair and equitable treatment in all aspects of personnel management without regard to political affiliation, race, color, religion, national origin, sex, marital status, age, or handicapping condition, and with proper regard for their privacy and constitutional rights.

Also, this is politicians using the civil service for their political benefit, 5 U.S.C. Section 2301 says (8) Employees should be - (A) protected against arbitrary action, personal favoritism, or coercion for partisan political purposes, and (B) prohibited from using their official authority or influence for the purpose of interfering with or affecting the result of an election or a nomination for election.

Also, a quote: "But [they] do have a federal constitutional right to be considered for public service without the burden of invidiously discriminatory disqualifications. And in the context of a challenge to a set-aside program, the "injury in fact" is the inability to compete on an equal footing

on a high percentage of the black vote in his race against George W. Bush.

What he is doing here is parading out the black appointees in front of blacks telling the blacks he will give them jobs.

Another similar thing: There was a story about Democrat Senator Daschle holding up judicial appointments wanting to get more minorities. This is part of this, he is telling blacks he will give them jobs.

Other evidence can easily be obtained by looking at what is going on in the civil service and looking at speeches.

THE ADMINISTRATION IS ALSO BEING USED TO PROMOTE PREFERENCES:

Mr. Bill Lann Lee of the Justice Department is trying to promote racial preferences. With government Briefs in discrimination cases, Mr. Lee is fabricating points, making up points and misrepresenting the law. To show this, in case Barry Ceminchuk v NASA, U.S. District Court, Southern District of Texas, Number H 97-3627 the government says one thing about their actions, and when these are shown to be unconstitutional and illegal they subsequently then make up other stories and keep trying to continue their actions.

The subsequent Briefs show them misrepresenting the law to the court in their Briefs with cases after the NASA case.

They have changed their story, fabricated things and are playing a game to steal money and misrepresent the law.

"THE REPORT ON US RACISM filed by the State and Justice Departments shows little more than how deeply entrenched the anti-American left is at the highest levels of government. One of the signatories to the report, Bill Lann Lee, has previously distinguished himself as an opponent of anti-discrimination law in California. As an NAACP lawyer, Lee designed a consent decree with the Los Angeles police and fire departments that would have circumvented California's anti-discrimination proposition 209. The decree was signed 10 days before the election, when it was clear the vast majority of California voters would support it. Lee argued that a proposition that clearly stated that the government should not make laws that discriminate on the basis of race and gender was "unconstitutional." Lee's racist and undemocratic consent decree was thwarted by lawyers for the

Immigration and Naturalization Service (INS) source, Judicial Watch said today that the Florida District of the INS has engaged in a systematic program of rushing aliens through the naturalization process to meet INS headquarters "goals" by October 1, 1999 and October 1, 2000. In Florida, a new citizen can register to vote up to October 10th.

An INS source told Judicial Watch that the program is nearly identical to the now infamous 1996 "Citizenship USA" program, wherein thousands of aliens - some with criminal backgrounds - were improperly and illegally rushed through the naturalization process in order to obtain Democratic votes for the presidential election. The Florida INS effort has been termed the "Backlog Reduction Program," - a neutral, bureaucratic-sounding title designed to lower the program's visibility with the media and the general public. INS examiners and clerks who met or exceeded headquarters goals and quotas for the program were rewarded with various types of bonuses, including an extra 40 hours of paid time off.

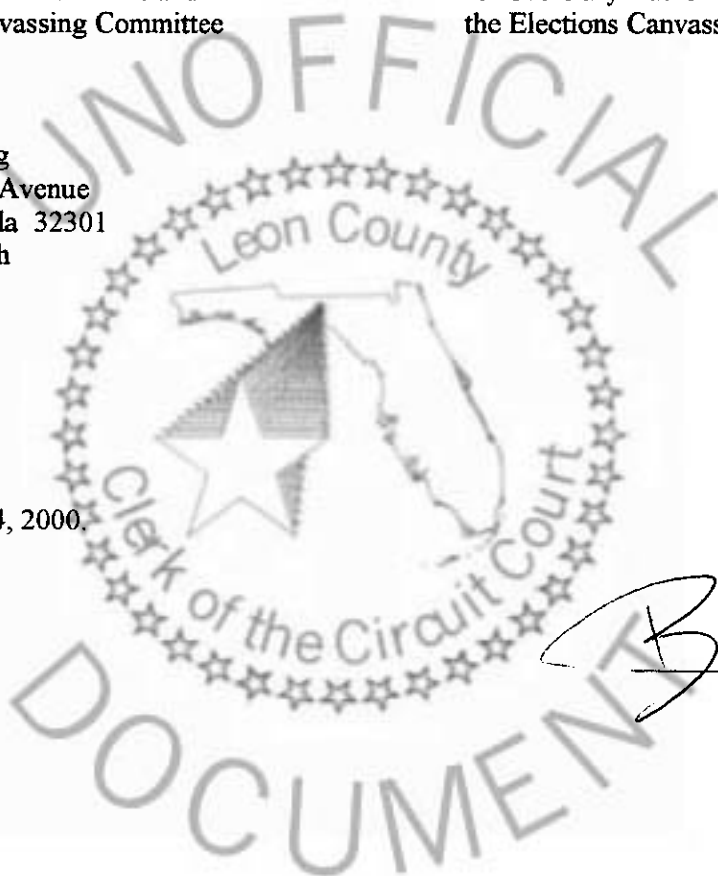


