PETITION FOR IMPOUNDMENT OF BALLOTS
IN THE FIRST JUDICIAL DISTRICT:
SANTA FE COUNTY, RIO ARriba COUNTY, AND LOS ALAMOS COUNTY

Petitioner Rita Nunez Neumann, through her counsel Scott & Kienzle, P.A. (Duncan Scott and Paul M. Kienzle III), petitions the Court for impoundment of ballots as follows:

1. Petitioner Rita Nunez Neumann is a resident of the State of New Mexico and the Republican candidate for Court of Appeals Position 4.

2. Petitioner is a candidate in every precinct in every county in New Mexico.

3. Petitioner requests this Court order impoundment of ballots, as defined in NMSA 1978, §1-14-8, including tally sheets, registration certificates, paper ballots, absentee ballots, statements of canvass, absentee ballot applications, absentee ballot registers, and emergency paper ballots, for the precincts within this judicial district set forth in Exhibit "A."

4. As required by NMSA 1978, § 1-14-9, Petitioner tenders a cash deposit of \$150.00, which is \$25.00 multiplied by the number of precincts (six) that she believes are encompassed in this petition. However, because of the difficulties in ascertaining the number of precincts that comprise early and absentee ballots, Petitioner requests that if there are more than six precincts, she

be allowed 20 days from the date of this petition to tender the additional cash deposit.

5. Petitioner requests this Court enter an order of impoundment in the form attached as Exhibit "B" pursuant to NMSA 1978, §1-14-8 through §1-4-12.

WHEREFORE, Petitioner Rita Nunez Neumann requests that the Court immediately enter an order of impoundment in the form attached as Exhibit "B" and for such other and different relief as the Court deems just and proper.
